



Singapore Visa Requirements

PHILIPPINE PASSPORT HOLDER, 30 DAYS W/OUT VISA
ROC PASSPORT HOLDER, must have TAIWAN VISA to enter SINGAPORE

TOURIST VISA REQUIREMENTS

- Duly accomplished Form 14A (revised form) printed on A4-size paper. Leave no blank space, if a question doesn't apply, please indicate "Not Applicable" (whole word not abbreviation) on the space provided.
- Copy of the applicant's passport biodata page (for at least six months valid from the date of entry)
- 2 recent passport-sized colored photo to be pasted on the top right corner of Form 14A. (colored photo taken within the last 3 months against plain white background without shadows, full face showing clear facial features without headgear, matt or semi-matt finish).
- Copy of ACR I-card/ SRRV (PRA)-ID/ SIRV (BOI)-ID
- Current immigration status in the Philippines for Tourist Visa
- Has sufficient funds for the period of stay in Singapore
- Confirmed onward/return air ticket
- Hotel voucher
- Applicants with business visit as purpose are required to submit additional requirements such as:
 - a. Form V39A/LOI (LETTER OF INTRODUCTION FOR VISA APPLICATION) duly and accurately completed and signed by the local contact. This may be issued by a local contact in Singapore.
 - b. Business profile of the Local Contact.
- Letter of Introduction for Visa Application or Form V39A (Countries Required) duly and accurately completed and signed by the local contact. This may be issued by a local contact in Singapore (an individual or a company). Any Singapore citizen or Singapore permanent resident who is at least 21 years old can act as a local contact. Photocopy of the local contact's Singapore Identity Card.
- Duly accomplished Data Privacy Consent Form (Data Privacy Act of 2012; RA10173).
- Authorization Letter where the visa application is submitted by the Applicant's representative.
